HOW TO APPLY:

Interested persons should send a **cover letter** and **Curriculum Vitae (CV) ONLY**. The Curriculum Vitae should include their day and evening telephone numbers, e- mail address and names and addresses of three referees. Shortlisted candidates will be **required** to produce academic certificates and testimonials as indicated on their CVs and Internship application summary.

NOTE TO APPLICANTS:

- The program is for one (1) year **non-renewable**.
- Remuneration will be as per the prevailing government rates subject to statutory deductions.
- **INCOMPLETE** applications will not be considered or reviewed.
- **TVETA WILL NOT EXTEND INTERNSHIP OR OFFER EMPLOYMENT** unless there is vacancy after the completion of the program which will be filled competitively.
- Note that a valid copy of student accident cover will be required when starting the internship.
- Only shortlisted candidates will be contacted.
