**Description:** Prescribes minimum requirements and guidelines for development of Occupational Standards, respective Competency-based Curricula and conduct of competency-based assessment for TVET programmes. The Standard also provides requirements for Curriculum approval by TVETA. Sample formats for a competency unit in an Occupational Standard and unit of learning in a CBET Curriculum are provided in the Standard.

The Standard also stipulates the roles and responsibilities of key players in implementing RPL which includes TVETA; employer; industry; TVET RPL Centre; Assessment body; RPL Coordinator; RPL Counsellor/Advisor; RPL Assessor and RPL applicant.

## 3. TVET Standard — Trainers Qualification Framework (TQF) — Requirements and Guidelines Number: TVETS 03: 2019 Price: Kshs. 3,320.00

**Description:** Prescribes the minimum requirements for Technical Instructors, Technical Trainers, Programme Developers and Training Managers engaged in implementation of CBET in TVET. The stipulated minimum require-

ments focus on CBET training professionals' qualifications levels and prerequisite competencies to be covered in the trainer's professional education programmes for those various TVET professionals. Each of the TQF categories has an independent Standard with details of competences required.

The Standard provides minimum requirements to be met in the following areas: application for Centre of Excellence Status; renewal of Centre of Excellence Status; governance, leadership and management; infrastructure; training programmes; trainee support; research and innovation; entrepreneurship, incubation and mentoring support; collaboration and partnerships, and quality assurance.

**Description:** Prescribes requirements and guidelines for TVET assessment centre in Kenya on the following: accreditation of assessment centre, partnership agreements, assessment centre design and planning, assessment centre resources including human resources, preparing assessment delivery, assessment delivery, communicating assessment outcomes and post-assessment review. The Standard is designed to support TVET Institutions and industry to provide suitable resources for CBET assessment.
